Our Autumn event 2014 was a talk on the Beau St. Hoard

Stephen Clews, Director of the Roman Baths Museum, gave a fascinating talk and power point presentation on The Beau Street Hoard at the BHRA Autumn event. This amazing collection of over 17000 silver coins spanning a 300 year period during the Roman occupation of Bath, was discovered when archaeologists were investigating the new Gainsborough hotel site close to the Thermae Bath Spa complex. Residents were able to handle Roman coins, and consider the weight of the bagged coins. It was so interesting to be told more about this extraordinary discovery.

Colin Martin is standing down as our Chairman

We'd like to thank Colin Martin who has chaired our Association since 2009 is stepping down at the AGM in March. Colin has led the Association with wit and wisdom over the last 6 years, he has kept the focus on fostering community relations and taking up the issues that most affect life on the hill, where a community consensus has been important.

Report from FOBRA - Federation of Bath Residents' Associations

Peter Dawson, Group Manager Transport and Planning Policy has agreed to speak at the AGM on 19 March.

This report has been prepared to provide some background.

TRANSPORT

For many years FoBRA, on behalf of the Bath residents' associations, has been urging the need for a Transport Strategy to tackle Bath's congestion and pollution problems. In recognition of this FoBRA was represented on the Transport Commission established by Banes under the chairmanship of Sir Peter Hendy, a Widcombe resident and Transport Commissioner for London. The Strategy developed by the Commission was subject to consultation during last spring and summer and approved by Banes last November.

This is a major step forward. The Strategy, which is expressed in terms of high level objectives, is available on the Banes website. It sets out a long term vision of Bath enhancing its unique status by adopting measures that promote sustainable transport and reduce the intrusion of vehicles, particularly in the historic core. The purpose is to foster economic growth, enhance Bath's special character as a World Heritage City and improve the quality of life of residents.

These objectives will be achieved by reducing congestion to make it easier to move around the city and improving air quality by reducing vehicle carbon emissions.

Key proposals include:

- Developing a walking/cycling strategy to make Bath the UK's most walkable city;
- Better management of HGV's in the city;
- Continued expansion of Park and Ride sites ;
- A new location for coaches to park after dropping visitors off in the centre.

Fobra warmly welcomes the Strategy as a key opportunity to tackle the congestion and air pollution in the City. Nitrogen dioxide levels along most of the main road network are 50% above the legal limit at which pollution becomes a potential health risk, especially of heart and lung disease. The Supreme Court has ruled that the government has a legally enforceable duty to bring pollution down to the levels required by its own laws.

Traffic has a major negative impact on the overall appearance and amenity of the city. Queen Square, is little more than a roundabout on the A4. The Circus is a rat run. Pollution and vibration take a toll on the fabric of the city.

The Strategy was voted with all party support, which is crucial, as its implementation will stretch over many years. It is a good start but implementation will be critical.

Fobra supports the vision of reducing the intrusion of vehicles in the city, especially in the city core, but would like to see the city centre free of all but essential traffic.

However, traffic on the key arterial routes must be tackled too. Through traffic, especially HGVs, must be removed from the city. An A36/46 link road is essential, since it is now clear from a Department for Transport decision that traffic cannot be banned from Bath in the absence of a new alternative route. Fobra welcomes the Council's commitment to work with Wiltshire and the Department for Transport on this. Fobra supports a Park and Ride to the east of Bath. All the Park and Rides should operate later into the evening and have secure overnight parking, so that they can be used by evening and overnight visitors. Fobra supports more pedestrian access, cycling, better public transport and improved freight delivery. But these will have limited impact if motorists remain able to drive into the centre and park at will. So we support the proposals to develop a traffic management plan for the city and to reduce visitor parking in the centre, as the Park and Rides are expanded.

The strategy includes work on a Low Emission Area (LEZ). We welcome this, but the LEZ should cover the whole city centre, not just a small area close to the bus station as currently proposed. Council Leader, Paul Crossley, has agreed in principle that the strategy should be more ambitious and Fobra is urging that it should cover the whole of the centre, plus Great Pulteney Street and the Henrietta area.

Looking ahead to implementation a Transport Plan will be necessary containing detailed projects with timescales and budgets, and with annual progress reviews. An essential element of the Plan will be a traffic management plan to reduce traffic volumes in the centre and other areas.

The strategy should recognise the connection between land use and traffic. Traffic modelling studies should be carried out when major developments are considered. Fobra has not yet seen an assessment of the traffic implications of the major Riverside Enterprise Area development or of the new housing developments planned on the edges of the city.

The Transport Strategy complements the Placemaking Plan. In consultation on the Placemaking Plan Fobra emphasised the need to ensure that the infrastructure necessary to implement the Transport Strategy is delivered in a timely manner. Infrastructure to remove through traffic, especially HGVs, from Bath is particularly important but depends on achieving agreements with Wiltshire and the Highways Agency. Any information our guest speaker can give us on progress in the discussions already underway on this last issue; on the implementation timetable for the Strategy as a whole, and on funding, will be particularly helpful.

Closer to home, our guest may also be able to update us on speed limits and enforcement on the Hill; when long promised real time indicators will be installed at the bus stops and the implications of continuing growth of the University for the frequency and vehicle quality of our bus services.
